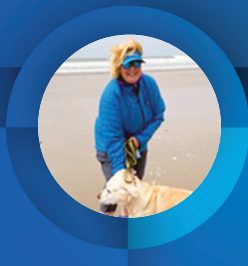
As a retiree member of NTEU, for only \$42 a year, you give us the power and clout we need to effectively defend the retirement you earned and were promised when you began your federal career.
